Bylaw No. 3/16

A bylaw to amend Bylaw No. 20/14 known as the Zoning Bylaw of the Rural Municipality of Meadow Lake No. 588.

The Council of the Rural Municipality of Meadow Lake No. 588, in the Province of Saskatchewan, enacts this bylaw to amend Bylaw No. 20/14 as follows:

- 1. The **Zoning District Map** referred to in Section 7 and Sheet 6 is amended by rezoning from A – Agriculture District to C1 – Commercial District the land legally described as Parcel C, Plan 101628794 Ext 62 (9.58 acres) in the NW-35-58-17-W3M as shown within the bold outline on the attached Schedule “A” and forming a part of this bylaw.
- 2. This bylaw shall come into force and take effect when approved by the Minister of Government Relations.

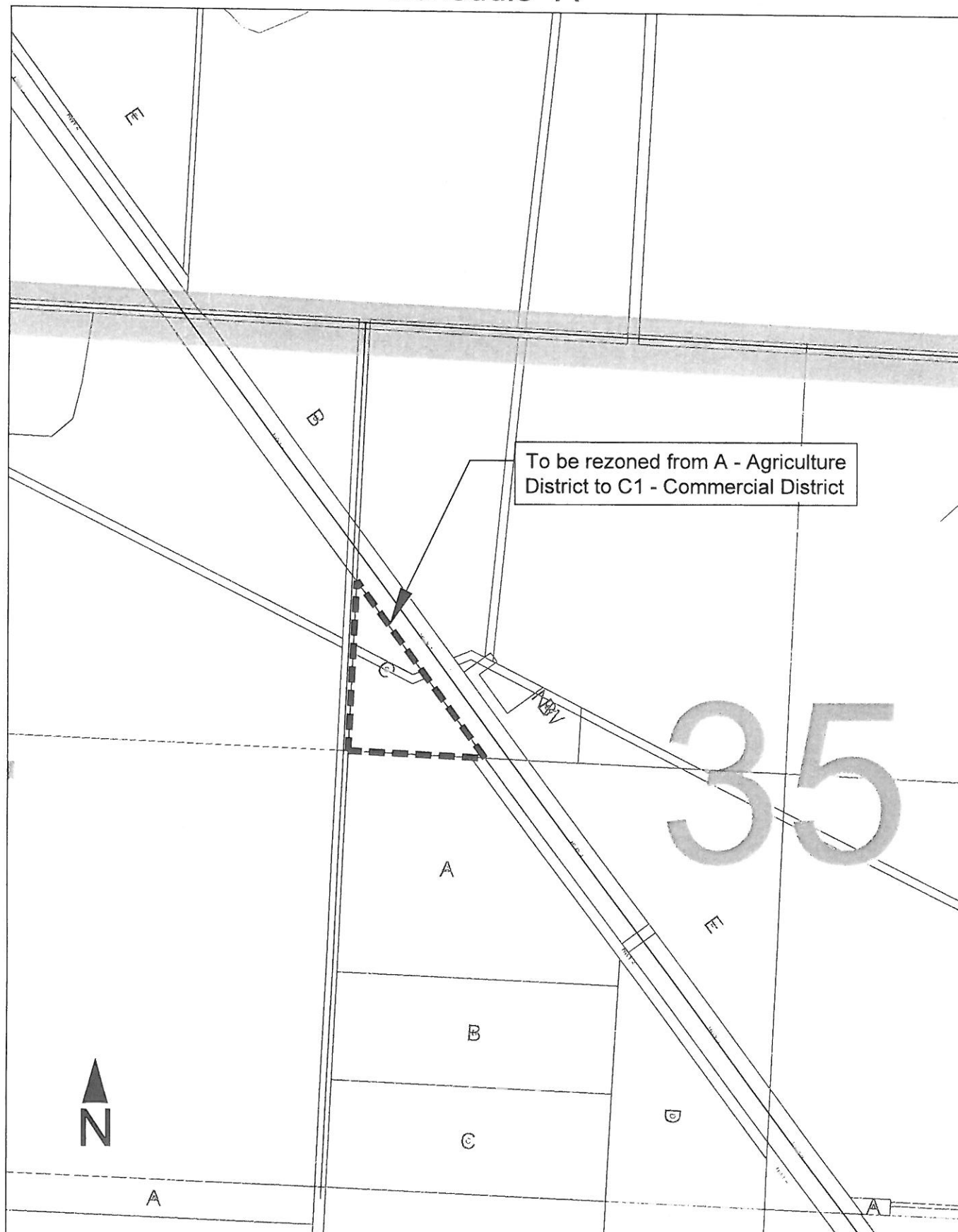
