BYLAW NO. 5/16

A BYLAW OF THE RURAL MUNICIPALITY OF MEADOW LAKE #588, IN THE PROVINCE OF SASKATCHEWAN, TO AMEND THE NORTH OF DIVIDE PLANNING DISTRICT AGREEMENT

WHEREAS, The Council of the RM of Meadow Lake #588 has ADOPTED Bylaw No. 9/15 to enter into an Agreement to be a member of the North of Divide Planning District; and

WHEREAS, The Council of the Rural Municipality of Loon Lake No. 561 and the RM of Beaver River No. 622 have provided notice pursuant to Section 11 of said Agreement to terminate their affiliation in the North of Divide Planning District; and

WHEREAS, The Council of the RM of Meadow Lake #588 does not object to Rural Municipality of Loon Lake No. 561 and the RM of Beaver River No. 622 terminating their affiliation in the North of Divide Planning District; and

WHEREAS, said Agreement provides that each affiliated municipality shall prepare and consider a bylaw to amend said Agreement by removing reference to the municipality proposing to terminate its affiliation;

NOW THEREFORE, THE COUNCIL OF THE RM OF MEADOW LAKE #588 ENACTS AS FOLLOWS:

1.0 This Bylaw shall be sited as the "Bylaw to Amend the North of Divide Planning District Agreement".

2.0 AMENDMENTS TO PLANNING DISTRICT AGREEMENT

The North of Divide Planning District Agreement, which is attached to and forms part of Bylaw No. 9/15, is amended as follows:

- A. The clause identifying the parties to the agreement, Section 2, and Section 3(i) shall be amended by deleting reference to "Rural Municipality of Loon Lake No. 561 and the RM of Beaver River No. 622".
- B. Section 3 shall be amended by deleting subsections b) and c) in their entirety.
- C. Section 16 shall be amended by deleting "Rural Municipality of Loon Lake No. 561 and the RM of Beaver River No. 622" as parties to the agreement.

3.0 EFFECTIVE DATE

This Bylaw shall come into force and take effect upon receiving the approval of the Minister pursuant to Section 106 of *The Planning and Development Act, 2007*.

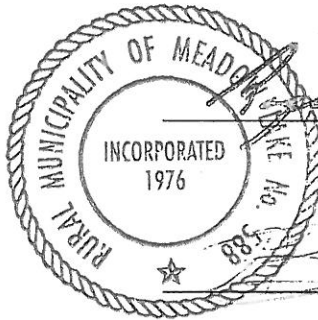
