

RURAL MUNICIPALITY OF MEADOW LAKE No 588

A ByLaw to designate the Property known now as DIAMOND FOUR LOG CABIN, formerly known as ST. DAVID'S ANGLICAN CHURCH and CEMETRY at ST. CYR as being of Historical value.

WHEREAS Part 111 of the Heritage Property Act, 1980, authorizes the council of a municipality to enact bylaws to designate real property, including all buildings and structure thereon, to be of architectural, historical or natural value or interest;

WHEREAS the Council of the Corporation of the Rural Municipality of Lake No 588 has caused to be served on the owners of the lands and premises now known as the DIAMOND FOUR LOG CABIN and formerly known as ST. DAVID'S ANGLICAN CHURCH and CEMETRY in the ST, CYR district at MEADOW LAKE a Notice of Intention to be published in two issues of the local newspaper with general circulation in the municipality with the first publication at least twenty-one (21) days prior to the date of consideration of the bylaw and with the last publication at least seven (7) days prior to the date of that consideration;

WHEREAS no Notice of Objection to the proposed designation has been served on the Secretary of the municipality;

THEREFORE, the Council of the Rural Municipality of Meadow Lake No 588 enacts as follows:

1. There is designated as being of historical interest the real property now known as the DIAMOND FOUR LOG CABIN and formerly known as ST. DAVID'S ANGLICAN CHURCH AND CEMETRY in the ST. CYR district at MEADOW LAKE, Saskatchewan, and legally described as:
All that portion of the South West Quarter of Section Thirty-Three(33), in Township Sixty (60), in Range Fourteen (14), West of the Third Meridan, in the Province of Saskatchewan, in the Dominion of Canada, described as follows: Commencing at a point on the north limit of the Surveyed road shown on a Plan of Record in the Land Titles Office for the Battleford Registration District as NO A. Y. 1289, Five Hundred and Sixty-seven and Five Tenthths (567.5) feet from the West boundary of the said quarter section; thence Easterly along the said North limit of the said Road Two Hundred and Eight and Seven Tenthths (208.7) feet; thence Northerly at right angles to the North limit of the said roadway Four Hundred and Seventeen and Four Tenthths (417.4) feet; thence Westerly and parallel with the said North limit of roadway, Two Hundred and Eight and Seven Tenthths (207.7) feet; thence Southerly to the point of commencement containing Two acres more or less.
The significance of the site is as follows:

Pioneer Church built and used by the first settlers of the St. Cyr District and to be preserved for continued use by the present community as a activity centre.

2. The Municipal Secretary is hereby authorized to cause a certified copy of this ByLaw to be registered against the property described above in the proper Land Titles Office.

3. The Secretary is hereby authorized to cause a copy of this ByLaw to be served on the owner of the aforesaid property and on the Minister of Culture and Youth, and to cause notice of the passing of this ByLaw.
